Mukund mama is the elder brother of Shri Kamakshi Baba and has been very close to Him all through his life. So after Kamakshi Baba attained Samadhi in 1991, devotees started approaching Mukund mama with their problems. He prays to Kamakshi Baba and conveys the answers to the devotees.

Sumathi (name disguised) is one such person who Mukund mama helped. She has not met Guruji but came to know about Guruji after getting married into the family of Guruji's relations. She now lives in the US. She didn't know about Guruji before marriage and what devotion she has developed today has been on the strength of being told about Him by Mukund mama and her family members and her own personal experiences where she has experienced miracles. She is very devoted to Mukund mama and whenever she visits India she makes it a point to meet Mukund mama in Chennai.

A few years after marriage she conceived. As both husband wife were settled in the US, the delivery was planned to be done in the US. Sumathi was admitted to the labour ward. Lying on the bed Sumathi used to hold Guruji's photo in her hands and kept holy Kumkum from *DMS* under her pillow. After a few days Mukund mama received a frantic call from her "Mama,I am in a lot of pain. Every time it appears that I am going to deliver, I have unbearable pain but the delivery does not happen. This has been repeating a few times. Please tell me what to do. Should I proceed with a Caesarian?"

Mukund mama asked her to hold the line. He prayed to Guruji and after getting the response, told her "Guruji says there is no problem. The head of the to-be-born babe is larger than normal. Ask the doctors to give you an injection on your back side. Ask the nurse to keep on pressing down your stomach. Breathe hard. You will deliver. Guruji's blessings are on you".

Sumathi thanked Mukund mama and hung up. Next day early morning Sumathi delivered after following the instructions of Mukund mama.

This is one of the several instances where Mukund mama has prayed to Guruji and communicated the answers.

A striking parallel case is that of Mr.Bhatt from Gujarat.Mr. Bhatt had never met Guruji but learnt about Guruji (and Mukund mama) from his friend who is an ardent devotee. Suddenly one day the devotee got a frantic and worried call from Mr. Bhatt. It seems his wife had been having chest pain and the diagnosis in Gujarat had not been satisfactory. She had been taken to Mumbai. "Tomorrow she is going to take tests at Mumbai, can you ask Guruji's brother Mukund mama what the problem is?"

Mukund mama prayed to Kamakshi Baba. Very confidently and straight like an arrow Mukund mama responded: "It's nothing but gas. Tell her to take antacids. She will be alright". This sensational response of Mukund mama was promptly conveyed to Mr. Bhatt by the devotee. No doubt Mr. Bhatt did feel relieved but he was not sure it made sense.

After a week the devotee got a call from his shell shocked friend "Your Guruji is 100% correct. It was just gas. She was suffering for 6 months with chest pain. I am not able to believe this. All tests are negative. Now she is taking antacids for the last one week and there is no trace of the pain".

We are indeed blessed to have a great soul like Mukund mama in our midst.

Report of Dr. Geeta Badrinath presented on 19th Feb.'12

From the Doctor's desk



An interesting case study of a patient at our centre was presented.

A rare case of acalasia cardia was treated conservatively.

On an unusually wet December afternoon a lady came into the medical centre wailing loudly.

She was carrying in her hand a small bundle which she placed on the table. Inside the cloth bundle was a tiny little thirteen day baby weighing 1.3 Kgs. The baby named Poongothai was born pre-term and was vomiting feed.

It was found that the baby had acalasia cardia, a condition of the valve at the lower end of the food pipe. This valve has the function of preventing food from the stomach from going back into the food pipe. In acalasia cardia, this valve becomes incompetent. Usually such patients undergo surgery for tightening the valve.

We tried conservative management on the baby. The baby was fed in a slanting position on a board and kept like that with a board around chest. HR drops were prescribed for preventing reflux. The baby started gaining weight and number of times it vomited, reduced.

The mother was taught to keep the baby warm which is essential for pre-term, low birth weight babies. Now the baby is on solids and weighs 6.25 kgs which is appropriate for its 6 months' age.
