In the previous issue of Satsanga we had narrated the bus incident during the pilgrimage to Kedarnath. This is a continuation of the same incident but from a different angle.

Mr. M. Narayanan, a devotee who is now working in Kuwait dropped in at *DMS* office recently and whilst talking about Guruji the discussion veered to the above incident. Surprisingly he remarked that he too was a part of that group. What he has to say about it is indeed very interesting.

It would be relevant to mention here that Narayanan worked under Guruji. He was blessed to start his career working in his very first job with Guruji as his boss. On getting his appointment order from M/s. Crompton, (later Best & Crompton), he moved over to Allahabad to take up this assignment as a typist then and stayed and worked at the project site which was headed by Guruji. His narration is given below:

The driver was at the wheel to proceed to Kedarnath late in the evening but was feeling sick and uneasy. As time went by his discomfort became very acute and he felt exhaustion overcoming him. He was nowhere near the destination and at midnight there was little choice but to reach the destination. The hilly area and sloping roads made the drive dangerous. If not alert a wrong manoeuvre could send the bus and its occupants hurtling down several thousand feet.

Narayanan was seated next to Guruji. All passengers were aware the driver was unwell and the destination could be reached after driving for about an hour or so.

At this point Guruji sitting in His seat, got into prayers. He leaned forward. His face was close to the rear portion of the seat in front. He closed His eyes. Then He put both hands on the rear portion of the seat in front. The palms were open and were pressed against the front seat. To an onlooker it would appear that He was pushing the seat in front.

Narayanan knew that Guruji was in prayers. Strangely, the driver who was unwell, and in fact about to give up as he could not just do any more driving, felt much better. He seemed suddenly to get the energy to carry on.

The most remarkable happening in the incident was however something else: the very sharp and pointed observation by Narayanan about what he could perceive. ***The manner in which the bus was being driven changed. The driver had his own style of driving the bus but from that point on, that style disappeared. The way the bus was driven was exactly the way in which Guruji used to drive a vehicle. The mannerisms typical of a driver manifest in the way he horns, the way he changes gears and accelerates, the speed maintained, the way he slows down etc. Guruji had worked in projects where at the project site vehicles were available for senior executives to move around the site. Guruji used to drive jeeps at the sites. Narayanan, being in the same project and working under Guruji had often sat in the jeep when Guruji was driving. He could very clearly see the change in the way the bus was being driven. He very soon realised that the bus was in reality being driven not by the driver, who may have been physically at the wheel but by Guruji. Guruji continued to be in prayers sitting on the seat in the middle of the bus, eyes closed but through the body of the driver, He was driving the bus until it reached the destination.***

Narayanan had started his career as a typist but today he leads a team of four persons who report to him. He attributes his career growth as also the various happenings in his personal life entirely to the grace of Guruji.

Guruji takes full care of His devotees. There is not a single important event in the life of a devotee when Guruji has not taken care. Sometimes it is manifest and so uncanny, the devotee realises conclusively it is Guruji's work; there are times it is manifest but devotees may dismiss as a coincidence, only the faith of the devotee can differentiate it; but most times Guruji does all the "taking care" and the devotee does not even know what Guruji has done. Guruji does out of His love for the devotee without expectations. We cannot repay Him the kindness shown but the least we can do is to be conscious of this and express our gratitude to Him.

To get a Guru like Shri Kamakshi Baba is the greatest gift of life!

## **Registration of DMS Trust**

A major milestone was reached in June 2012 when DMS Trust was registered under the Indian Trusts' Act.

There are two registrations with the authorities that are relevant for a charity organisation:

- Under Sec. 80 G of the Income-tax Act. This is an approval given by the Income tax authorities to the organisation. Here the donors to the organisation get the income tax advantage popularly known as '80-G benefit'.
- Registration under the Indian Trusts' Act. This makes the Trust a 'public' trust notifying all authorities concerned within India about the existence of such a trust. There are two advantages because of this:
  - ✓ This gives the organisation its unique legal identity. Unless registered, the identity is not separate from that of its individual Trustees.
  - ✓ Secondly, by registering the Trust in this manner, the Trust gets access to Grants from various Government organisations and other funding bodies. Many times this is one of the important conditions most funding bodies require - that the organisation has been registered for a certain minimum number of years – say two or three years.

The new Deed and the registration must be followed up by a resolution by trustees that the new Trust acquires all Assets and Liabilities of the old Trust. This has also been done. The Legal opinion for the registration of DMS Trust has been given by S.Srinivasan, Chennai. The opinion is attached to this issue.

There were two reasons why the Trustees had not done the registration under the Indian Trusts' Act till now, although it was formed in 1991:

- The organisation was relatively small (in terms of its Corpus and its activities). Having a 'public' status was not warranted for its size.
- Having reached stability and looking ahead to a period of growth with ambition, registration gives the required aura of credibility/authenticity.

The first type of registration ie:- under sec 80G of the Income-tax Act was done long back (in 1990). Now with the registration under the Indian Trusts' Act having been achieved, both types of registration for DMS Trust are over !

**LEGAL OPINION regarding DMS TRUST having its Office at No.63, Jammi Building,  
Royapettah High Road, Mylapore, Chennai 600004**

DMS TRUST having its Office at No.63, Jammi Building, Royapettah High Road, Mylapore Chennai 600004 has been registered as a Trust under Document No.592 of 2012 Book IV on 4-6-2012 before the Sub Registrar (District Registrar Cadre, Mylapore) . Shri.Suresh Sundaresan, son of Late Sri.S.Sundaresan is the Author of the Trust and the Trust has been registered with a wishes and blessings of Late Sri.E.S.Govardhan, whose wishes the Trust has sought to fulfill by this registered document of Trust.

The objects of the Trust Deed have been enumerated in the Trust Deed itself in detail.



The property of the Trust and the Board of Trustees have been incorporated in the Trust Deed itself.

The Trust Deed gives powers for the Trust to open Bank Accounts and to operate the same including the power to the Managing Trustees to draw, make accept , endorse , discount , negotiate and execute cheques, bills of exchange and other negotiable instruments. The Trustee shall also have power to acquire, build, purchase, mortgage and take on leave or license or hire any property . The Trust is irrevocable. Further, the Trust also gives powers to frame and vary Schemes, Rules and Regulations for carrying out the objects of the Trust and the affairs of the Trust. In other words, the Trust is self contained and the Trustees powers are defined therein.

Since the Trust is now registered, you can operate all your activities within the ambit of the registered Trust Deed.

This is my considered Legal Opinion on the above said document.

## **Extract of Resolutions passed by Trustees of the newly registered DMS TRUST**

Resolutions passed at a Meeting of the Trustees held at Aaja Flats, Ground Floor, Old No.5, New No. 6, I Trust Main Road, Mandaveli, Chennai – 600028 on Saturday, 8th December 2012 at 6.00 PM

1. The Deed of Declaration of Trust dated 4th June 2012 registered as document No. 592 of 2012 with SRO Mylapore/Santhome was circulated. This was discussed.

RESOLVED THAT the DMS TRUST as per the Deed of Declaration dated 4th June 2012 duly registered before the Competent Authority shall supersede all other documents, deeds relating to the DMS TRUST.

2. Clauses 7 a, b and c were explained. It was considered necessary to elect Managing Trustee in terms of the Deed.

RESOLVED THAT the Trustees of the DMS TRUST duly elect and appoint Mr. Suresh Sundaresan, son of late S.Sundaresan, residing at No.11/2 (New), Yogambal Street, T-Nagar, Chennai 600017 as the Managing Trustee of DMS Trust.

3. RESOLVED THAT all properties and assets already held by the DMS TRUST shall vest with the Trust in consonance with the Deed of Declaration of the Trust dated 4th June 2012.
